

\$10K Multi-Deposit Bonus

TERMS AND CONDITIONS

INTRODUCTION

Legacy Capital Ltd, trading as "WB Invest" ("the Company") provide its clients with the opportunity to participate in the \$10K Multi-Deposit Bonus ("the Bonus"), as outlined in the Terms and Conditions ("the T&Cs") below. For any additional information and/or questions regarding the Bonus, please contact the Company at support@wbinvest.com.

TERMS AND CONDITIONS

- 1. The Bonus begins once the Company notifies the Client that it is in effect and ends when the Company informs the Client of its termination date ("the Bonus Period").
- 2. The Bonus is available to both new and existing Clients who hold at least one verified live trading account with the Company, excluding CENT accounts.
- 3. To qualify for the Bonus, Clients must make a minimum deposit of USD 500 (or the equivalent in another currency) in a single transaction.
- 4. Clients will become eligible to receive the Bonus after accepting the T&Cs for the first time. Thereafter, Clients must select "Claim Deposit Bonus" on the deposit page each time they complete a payment, where applicable.
- 5. The Bonus percentage may vary at the Company's discretion. The applicable Bonus percentage of the Client's deposited amount will be credited to the funded trading account. Clients should refer to the Company's official communications or contact Customer Support for more information on the current Bonus percentage.
- 6. Following the application of the Bonus, adjustments to account leverage may be made where deemed necessary. The Client Portal will display the maximum account leverage available, noting that certain instruments may have lower leverage caps.
- 7. The maximum total Bonus that may be granted to each Client is USD 10,000 in total (or other equivalent currency).
- 8. The Bonus is non-withdrawable and non-transferable trading credit. It may be used for margin but does not protect against losses. In the event of equity depletion or Stop Out, the Bonus is removed first. Only net profits and own funds are withdrawable

- 9. Internal transfers between the Client's trading accounts within the Company will result in the full removal of the Bonus. Similarly, the Bonus will not apply to internal transfers.
- **10.** Any withdrawal from a trading account that has received a Bonus will result in the complete cancellation and removal of that Bonus.
- 11. In the event of a Stop Out on a live account, the Bonus will be cancelled and removed. Stop Out levels apply as per the Trading Conditions available on the Company's website, regardless of the Bonus amount.
- **12.** The Bonus cannot be combined with any other bonuses or promotions offered by the Company.
- 13. If a Client has previously opted into and received another bonus or promotion, they may only participate in this Bonus by opting out of the previous one or by opening a new trading account and making a new minimum deposit of USD 500 (or other equivalent currency).
- 14. By participating in the Bonus, the Client consents to the Company processing their personal data for the purpose of administering the Bonus. The Company will not disclose client data except as specified in these T&Cs. Clients may withdraw consent at any time, though this may result in suspension or termination of participation in the Bonus.
- 15. The Company may request additional documentation from Clients before or during their participation in the Bonus. Failure to provide the requested documentation may result in suspension or termination of participation.
- 16. The Company reserves the absolute right, at its sole discretion, to decline registration or disqualify any Client from participating in the Bonus Scheme for any reason, including (but not limited to) breach of these T&Cs or the Client Agreement, or engagement in abusive trading practices. Disqualified Clients will forfeit their entitlement to the Bonus.
- 17. If a trading account has open positions and/or floating profit or loss at the time the Bonus is removed for any reason, the Company shall not be held liable for any resulting adverse effects.
- **18.** The Company may amend these T&Cs prospectively by posting an updated version on its website. Clients should review the website regularly.
- 19. Participation by related parties is prohibited. Only one Bonus scheme may be used per household, IP address, and device. "Related parties" include family members (spouses/partners, parents, children, siblings, relatives by descent) and entities or accounts
