

\$30 Sign Up Bonus Account

TERMS & CONDITIONS

- 1. The **\$30** Sign Up Bonus Account ("**the \$30** Sign Up Bonus" or "Account") is organized by Legacy Capital Ltd, trading as "WB Invest" ("**the Company**").
- 2. This promotion is available only to new clients who open a new MT4 Prime Account with a base currency of USD, EUR, GBP, or JPY. Existing live-account clients are not eligible.
- 3. Participants must be at least 18 years old to hold a live account.
- 4. To qualify for the \$30 Sign Up Bonus, the client must open a new Live Trading MT4 Prime Account and have it fully approved (KYC/AML completed).
- 5. Funds credited by the Company will be provided as non-withdrawable, non-transferable trading credit (the "Trading Credit" or "Credit").
- 6. The credited amount is valid for six (6) months from the date it is granted. However:
 - a) If the Account remains inactive for 30 days or more within the 6-month period, any credited amount, associated profits or remaining balances will be canceled, and the account will be terminated, regardless of whether the conditions in clause 7 were met.
 - b) Any withdrawal request submitted by the Client will result in the immediate cancellation of the Trading Credit.
- 7. The Client can withdraw funds from their Account only if the following conditions are met:
 - a) Profits in the Account are at least \$60 or more.
 - b) At least 1 lot has been closed.
 - c) A minimum of 20 closed trades that have been executed.
- 8. If the Account reaches a Stop Out level, any remaining credit amount will be settled accordingly.
- 9. Only one \$30 Sign Up Bonus is permitted to one person per household. Registration using the personal details of a family member (including brothers, sisters, spouses, ancestors, descendants, or other relatives), acquaintances, or any other individual/entity is strictly prohibited. If the Company suspects that the \$30 Sign Up Bonus was registered using another person's information, such as IP address, email, phone number, physical address, or utility bill, the Company reserves the right to cancel the credited amount without prior notice.



- 10. The Company reserves the right, at its sole discretion, decline, suspend or cancel the \$30 Sign Up Bonus at any time without prior notice, to decline the promotion to any applicant, or to terminate the \$30 Sign Up Bonus of any new client if it deems such action reasonable or necessary.
- 11. Company's employees, its service providers, associates, and/or their family members are not eligible to participate in or claim the \$30 Sign Up Bonus.
- 12. The \$30 Sign Up Bonus Promotion cannot be used in conjunction with any other promotion.
- 13. By participating in this \$30 Sign Up Bonus promotion, the Client consents to the Company processing any personal information provided during registration and participation. This information will be collected and processed by the Company and its related entities solely to the extent necessary to administer and manage the promotion. Clients may withdraw their consent for personal data processing at any time; however, doing so may result in disruption, suspension, or termination of their participation in the \$30 Sign Up Bonus.
- 14. The Company may require the Client to provide additional documentation before or during their participation in the \$30 Sign Up Bonus promotion. The Client is obligated to submit the requested documents; failure to do so may lead to the disruption, suspension, or termination of their participation in the promotion.
- 15. Clients who submit false or misleading information during the account opening process will be disqualified from participating in the \$30 Sign Up Bonus promotion.
- 16. Clients who submit incorrect or fraudulent information during the OTP verification process will be disqualified from participating in the \$30 Sign Up Bonus promotion.
- 17. The Company reserves the right to cancel any accrued profits or refuse any withdrawal requests if the client's mobile number cannot be successfully verified at the time of the request.
- 18. Failure to comply with any of the above terms, or with the Company's general trading terms, may lead to the immediate cancellation of both any improperly obtained profits and the credited amount.

To the fullest extent permitted by applicable law, the Company shall not be liable for any loss, cost, or damage arising from or in connection with the suspension, cancellation, removal, or rejection of any Trading Credit (including any resulting Stop Out or automatic closure of position(s)).
